

## 2025 BLOOMFIELD APPLE FESTIVAL, INC. VENDOR CONTRACT

As a participating vendor in the 2025 Bloomfield Apple Festival, I agree to the following:

1. That the Bloomfield Apple Festival, Inc. and the Town of Bloomfield, Indiana shall not be responsible for any injury or loss, arising out of or relating to the Vendor's use of the Town's property and/or conduct or omissions pursuant to the Contract, regardless of whether such injury or loss is to the Vendor's person or property, or to any third party or to the public, regardless of whether such loss or injury arises out of or is related to any act or omission by the Bloomfield Apple Festival, Inc., The Apple Festival Committee, or the Town. The Vendor agrees to indemnify and hold the Bloomfield Apple Festival, Inc. and any of its agents, and the Town and its agents harmless from any such loss, injury, claim, or liability arising out of or relating to the Vendor's use of the Town's property and/or conduct or omissions pursuant to this contract. All insurance must be paid for and held by the Vendor, including set-up. The Vendor shall be responsible for any legal fees, court costs, and expenses, incurred by the Town and/or the Bloomfield Apple Festival, Inc. in compelling or attempting to compel compliance with this Contract or in remedying or attempting to remedy any breach of this Contract by the Vendor. All decisions of the Bloomfield Apple Festival, Inc. and the Town are final and not appealable except as otherwise required by law.
2. All Vendors selling food items, whether for profit or not, shall have and are responsible for the procurement of the proper certificates and licenses from the Greene County Department of Health PRIOR to opening for business. Any food Vendor who does not have the proper authorization from the Greene County Department of Health will NOT be allowed to open for business and will be ordered to leave the park without any refund.
3. There will be NO REFUNDS in the event of rain, no-show by the Vendor, or expulsion or removal for breach of any of the terms of the contract. Only members of the Bloomfield Apple Festival, Inc. may allocate space and determine the location of Vendors. Size and location of spaces will be strictly enforced. There will be a \$25 charge for returned checks. After a bad check is received, Vendors will have to pay by cash or money order.
4. All Vendors agree to keep the immediate area around their booth, tent, shelter house, trailer or assigned space clean and free of clutter and hazards. All Vendors agree to conduct themselves appropriately. All Vendors further agree that they will comply with all requirements and requests of the State Fire Marshall, Bloomfield Fire Department, Bloomfield Town Council, any law enforcement personnel, and the Bloomfield Apple Festival Inc. or its agents, as well as applicable Town ordinances and laws of Indiana and the United States.
5. Absolutely NO alcoholic beverages of any kind, no items containing images or depictions of illegal items or activity, and no weapons of any kind are permitted at the Apple Festival. The Bloomfield Apple Festival Inc. and its members have final say on what may or may not be sold. If you are found to be in violation of this term, any member of the Bloomfield Apple Festival Inc., you may be subject to expulsion from the festival. If you are found to be in possession of alcoholic beverages or any other illegal substance at the Bloomfield Town Park, the Bloomfield School grounds, or any other areas being used by the Apple Festival, you will be charged with a criminal offense and ordered to leave the festival immediately.
6. Electrical and water hook-ups are available. Vendors MUST use the electrical services (outlets) available, unless otherwise approved by the Bloomfield Apple Festival Inc. There will be NO re-wiring or hardwiring of the electricity allowed. Extension cords must be at least 12-gauge. No splices in cords will be allowed. No stakes are allowed in the ground due to underground wiring in the park. If stakes are discovered, the Vendor SHALL PAY to the Bloomfield Apple Festival Inc. \$50 per stake and remove the stakes. By order of the State Fire Marshall, all Vendors MUST HAVE AN EASILY ACCESSIBLE, CHARGED FIRE EXTINGUISHER in his/her Vendor space. All tarps must be fire retardant.
7. This contract is the entire contract between Vendor and the Bloomfield Apple Festival, Inc. and the Town. This contract may not be amended or modified unless done so in writing and signed by all Parties.
8. NO VEHICLES ALLOWED IN THE PARK unless permitted by Apple Festival Personnel.

# Set-Up and Tear Down And Non-Negotiables Contract

## Bloomfield Town Park

### Thursday Set-up:

Starts at **8AM** on and must be completed by **8PM** that evening.

There will be designated parking spots to unload.

Once you have checked in we will let you know when and where you can park to unload.

If driving in the park is permitted, you will have a 30 minute window to drive in, unload and exit the park.

### Saturday Tear Down:

**May start when the entertainment ends.**

Driving in the park is **NOT** permitted on Saturday night.

### Sunday Tear Down:

May start as early as 4PM. **Must be completed by 8PM** that evening.

Driving in the park will only be permitted when allowed by Apple Festival personnel.

All vehicles must be parked outside of the exhibit area during the Bloomfield Apple Festival. Vendors will be allowed to park in the designated parking spots for a maximum of 20 minutes to unload or load only.

**THERE ARE TO BE NO VEHICLES INSIDE THE BLOOMFIELD PARK** unless permitted by Apple Festival Personnel.

Please initial next to each item acknowledging your understanding that these items are prohibited from sale, use, and/or possession at the Bloomfield Apple Festival and can result in the termination of your Contract without refund.

In the event the Bloomfield Apple Festival, Inc. it's members, volunteers or officers, are named as defendant(s) in any action covered by this indemnification and hold harmless agreement, then in such an event, the undersigned vendor does hereby agree to immediately accept the tender of said defense, defend said action, and hold the Bloomfield Apple Festival, Inc. it's members, volunteers and officers, harmless of any liabilities thereon.

I understand that the vendor space must be open during Bloomfield Apple Festival hours. On behalf of myself and the organization I represent, I acknowledge receipt of the vender contract and the rules and regulations related to participating as a vender and will abide by the rules and regulations.
